  - Perpu No. 1/2020 regarding State Financial Policy and Financial System Stability for Handling the 2019 Corona Virus Disease (Covid-19) Pancemic and/or In Order to Face Threats that Endanger the National Economu and/or Financial System Stability;
  - (ii) The Government Policies No. 21/2020 regarding Large Scale Social Restrictions in the Context of Accelerating the Handling of Corona Virus Disease 2019 (COVID-19);
  - (iii) The Government Policies No. 9/ 2020 regarding Determination of Large Scale Social Restrictions in the Context of Accelerating the Handling of Corona Virus Disease 2019 (COVID-19);
  - (iv) Instruction of the Governor of the Special Capital Region of Jakarta No. 33 year 2020 concerning Optimization of Anticipation and Prevention of Corona Virus Disease Transmission (COVID-19) by Maintaining Safe Distances Between Citizens in the Community (Social Distancing Measure) in the Community Environment.
